A 10% discount is applied to prepaid advertisements of the same size placed in the *2009 Annual Breeders' Guide and Stallion Directory* and in all four 2009 issues of the AHS magazine beginning with the upcoming spring issue. **No agency discount is offered.** Checks payable to the American Hanoverian Society must accompany this agreement. This agreement must accompany any insertion order. Advertising materials which are not paid for in advance will not be published. Any alterations necessary to make submitted materials camera-ready for the format stated on the ADVERTISING RATE AND SPECIFICATIONS SHEET will be billed to the advertiser by AHS.

- **Ads must be supplied camera-ready. Color ads must include a pre-press proof.** Any changes, revisions or conversions necessary to make an ad camera-ready will be billed at \$80/hour. One hour minimum. Each additional 15 minutes billed at \$20. **Advertisers must provide color key proofs for 4-color ads or they will be created by the printer, and advertiser will be billed \$45/page.**
